# SEASONS TRACE SINGLE FAMILY ASSOCIATION Quarterly Meeting Minutes March 20, 2023

Financial statements and budget information presented for board review by Treasurer Ed Overton.

Significant drop in balances between the Nov \& Dec financials due to an error where Evernest wrote additional checks to the Rec Association. This issue has been corrected and those checks had stop payments placed on them. The Rec Assoc have received the correct amount as of now.

Allison reported on Feb figures. Discussion of moving the reserve funds monthly. Allison proposed moving all reserve money from Truist \& Chesapeake bank accounts to CIT Bank reserve account. Board recommends keeping it with Chesapeake and closing Truist.

Discussion of where vendors should send bills. Advised Allison to send payments to Rec Assoc 6 equal payments from April-Sept.

Jenn motioned that the treasurer's report be adopted and held for audit, Ed 2nd. No objections.

## Committee Report:
