New Covenants Update

Ted Johnson, Rowena Seaman, and Brian Sorrell have met with the lawyer and are finalizing a new draft for replacing our antiquated HOA Covenants. A draft will be available for public review soon so we can begin the rally to gain support for getting the 2/3 vote necessary to ratify the changes. We will post information explaining the benefits of the new covenants, which include clearer guidelines for architectural review and modern language for understanding the regulations that would help avoid legal conflicts in the future. There will be a town hall meeting with the lawyer so you may ask questions and give feedback. Look for the meetings later this year to be advertised on the sandwich board, the new advertisement sign at the entrance to Seasons Trace, and here on the website.

Good Neighbor Grant Update
